**2. ADMINISTRATION**

<b>1.</b>	Only a member of a Club in the State issuing the Organising Permit is permitted to participate in the Activity.
<b>2.</b>	The Club should maintain a register of all persons who enter the Circuit for the activity.
<b>3.</b>	The Age Divisions offered must be in accordance with the <b><u>Karting Australia Appendix 1 – Kart Fun Sessions.</u></b> <ul style="list-style-type: none"> <li>• Cadet 9, Cadet 12 and 4SS Cadet Drivers are permitted on a Track at the same time.</li> <li>• Junior Drivers are not permitted on the Track with any other age division.</li> <li>• Senior Drivers are not permitted on the Track with any other age division.</li> </ul>
<b>4.</b>	<b>BOOKING</b>
<b>4.1.</b>	The number of positions in the Activity is strictly limited by Government Directions/orders. Accordingly, bookings are essential and are accepted strictly on a 'first come first served' basis. There will be NO ENTRIES ACCEPTED ON THE DAY.

### 3. SPECIFIC COVID-19 RESTRICTION AND MITIGATION REQUIREMENTS

<b>1.</b>	<b>PERMITTED AND NON-PERMITTED PERSONS</b>
<b>1.1.</b>	<b>No person who has symptoms consistent with COVID-19 (this includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, lack of smell or fatigue) is permitted to attend the Circuit or participate in the Event.</b>
<b>1.2.</b>	<b>Any person who starts to feel unwell or to exhibit symptoms of COVID-19 during the Event must immediately avoid contact with all persons at the Circuit and MUST IMMEDIATELY LEAVE the Circuit.</b>
<b>1.3.</b>	<p><b>Note – The Organising Club must ensure that the maximum number of people (the combined total of Essential Personnel and Permitted Persons) permitted to gather in total at an Event and in groups in accordance with State Public Health Authority Orders/Directions/Regulations is not exceeded at any time prior to or during the Event.</b></p> <p><b>Essential Karting Personnel</b> is defined as:</p> <ul style="list-style-type: none"> <li>• Club President, Vice President, Treasurer, Secretary; and</li> <li>• COVIDSafe Officer</li> <li>• Essential Officials identified in Section 1.6 of these Regulations</li> <li>• First Aid Attendant; and</li> <li>• Administration and Access Control Attendant/s</li> <li>• Event Operations staff (includes but is not limited to canteen staff, cleaners etc).</li> </ul>
<b>1.4.</b>	<p><b>Permitted Persons</b></p> <ul style="list-style-type: none"> <li>• A Licensed Driver (Driver) who has booked their entry in the Event plus a maximum of 1 other people per kart who must be either: <ul style="list-style-type: none"> <li>○ The Parent, Legal Guardian, or family member of the Driver; or</li> <li>○ The Participant License Holder for the Driver; or</li> <li>○ A Mechanic whose sole task it is, is to prepare, adjust, repair the kart as may be required;</li> </ul> </li> <li>• A Person who is approved by the Club to supply karting components and provide specialised karting service to any Permitted Persons in attendance at the Activity.</li> </ul>
<b>1.5.</b>	<p><b>Non-Permitted Persons</b></p> <p><b>SPECTATORS are not permitted to be in attendance.</b></p>
<b>2.</b>	<b>SOCIAL DISTANCING AND DENSITY REQUIRMENTS</b>
<b>2.1.</b>	Government prescribed Social Distancing measures must be observed at all times.
<b>2.2.</b>	Permitted Persons MUST NOT park or set their Pit up within 5 metres of another Permitted Person's Pit space.
<b>2.3.</b>	The use by Permitted Persons of any indoor facilities (other than toilets and washrooms) is strictly prohibited.
<b>2.4.</b>	<p>If food service is provided, it must comply with government requirements and be take away only.</p> <ul style="list-style-type: none"> <li>• Hand Hygiene must be available at any food service outlet.</li> </ul>
<b>3.</b>	<b>KARTING AUSTRALIA COVID-19 DECLARATION</b>
<b>3.1.</b>	<p><b>Under NO circumstances is ANYONE who has been overseas in the previous 14 days or been in contact with a person who is known to be COVID-19 positive, permitted to attend the Circuit.</b></p> <p>All Essential Karting Personnel and Permitted Persons MUST:</p> <ul style="list-style-type: none"> <li>• Complete and submit the Host Club's COVID-19 Travel Declaration <i>at least 24 hours before the commencement time of the Activity</i>; <a href="https://kartingaustralia.wufoo.com/forms/covid19-declaration-hurricane/">https://kartingaustralia.wufoo.com/forms/covid19-declaration-hurricane/</a> <ul style="list-style-type: none"> <li>○ If you have been overseas in the 14 days before the Activity or if you have been in contact with a Covid-19 Positive person, you will not be granted access to the Circuit.</li> </ul> </li> </ul>

<b>4.</b>	<b>HYGIENE FACILITIES - TOILET/WASHROOM FACILITIES and HAND SANITISER</b>
<b>4.1</b>	The Club is required to provide facilities to ensure general and sensible hygiene practices are maintained.
<b>4.2</b>	Toilet and washroom facilities at the Circuit must be open and available for use.
<b>4.3</b>	Washroom facilities must be properly equipped with liquid soap, running water and air hand driers or paper towels. <ul style="list-style-type: none"> <li>The toilets and washroom facilities must be cleaned between Sessions or as otherwise required.</li> </ul>
<b>4.4</b>	It is strongly recommended that Essential Karting Personnel and Permitted Persons bring their own supply of hand sanitiser for use in accordance with government recommendations.
<b>5.</b>	<b>HYGIENE – NON-SHARING OF EQUIPMENT</b>
<b>5.1</b>	The sharing of any equipment including but not limited to: tools, apparel, safety equipment, pens is not permitted.

#### **5. CIRCUIT SPECIFIC REQUIREMENTS**

<b>1.</b>	<b>KART RETRIEVAL</b>
<b>1.1.</b>	Kart trolleys will be given access to the Track.
<b>1.2.</b>	Retrieval of karts is at the discretion of the Grid / Track Control Official.
<b>1.3.</b>	A person must only enter the Track when permitted by an Official and then only when safe to do so.
<b>2.</b>	<b>ADDITIONAL VENUE REQUIREMENTS</b>
<b>2.1.</b>	No animals allowed anywhere within the facility.
<b>2.2.</b>	No unlicensed driving of motor vehicles permitted at the Circuit.
