3.	<ul> <li>The Age Divisions offered must be in accordance with the Karting Australia Appendix 1 – Kart Fun Sessions.</li> <li>Cadet 9, Cadet 12 and 4SS Cadet Drivers are permitted on a Track at the same time.</li> <li>Junior Drivers are not permitted on the Track with any other age division.</li> <li>Senior Drivers are not permitted on the Track with any other age division.</li> </ul>					
4.	BOOKING					
4.1.	The number of positions in the Activity is strictly limited by Government Directions/orders. Accordingly, bookings are essential and are accepted strictly on a 'first come first served' basis. There will be NO ENTRIES ACCEPTED ON THE DAY.

# 3. SPECIFIC COVID-19 RESTRICTION AND MITIGATION REQUIREMENTS

1.	PERMITTED AND NON-PERMITTED PERSONS						
1.1.	No person who has symptoms consistent with COVID-19 (this includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, lack of smell or fatigue) is permitted to attend the Circuit or participate in the Event.						
	Any person who starts to feel unwell or to exhibit symptoms of COVID-19 during the Event						
1.2.	must immediately avoid contact with all persons at the Circuit and MUST IMMEDIATELY LEAVE						
1.2.	the Circuit.						
	Note – The Organising Club must ensure that the maximum number of people (the combined total of Essential						
	Personnel and Permitted Persons) permitted to gather in total at an Event and in groups in accordance with State Public Health Authority Orders/Directions/Regulations is not exceeded at any time prior to or during the Event.						
	Essential Karting Personnel is defined as:						
1.3.	Club President, Vice President, Treasurer, Secretary; and						
	COVIDSafe Officer						
	Essential Officials identified in Section 1.6 of these Regulations						
	First Aid Attendant; and						
	Administration and Access Control Attendant/s  Front Operations staff (includes but is not limited to contact staff along one staff)						
	<ul> <li>Event Operations staff (includes but is not limited to canteen staff, cleaners etc).</li> <li>Permitted Persons</li> </ul>						
	<ul> <li>A Licensed Driver (Driver) who has booked their entry in the Event plus a maximum of 1 other people per kart</li> </ul>						
	who must be either:						
	The Parent, Legal Guardian, or family member of the Driver; or						
1.4.	<ul> <li>The Participant License Holder for the Driver; or</li> </ul>						
	<ul> <li>A Mechanic whose sole task it is, is to prepare, adjust, repair the kart as may be required;</li> </ul>						
	A Person who is approved by the Club to supply karting components and provide specialised karting service						
	to any Permitted Persons in attendance at the Activity.						
1.5.	Non-Permitted Persons						
1.5.	SPECTATORS are not permitted to be in attendance.						
2.	SOCIAL DISTANCING AND DENSITY REQUIRMENTS						
2.1.	Government prescribed Social Distancing measures must be observed at all times.						
2.2.	Permitted Persons MUST NOT park or set their Pit up within 5 metres of another Permitted Person's Pit space.						
2.3.	The use by Permitted Persons of any indoor facilities (other than toilets and washrooms) is strictly prohibited.						
2.4.	If food service is provided, it must comply with government requirements and be take away only.						
	Hand Hygiene must be available at any food service outlet.						
3.	KARTING AUSTRALIA COVID-19 DECLARATION						
<u> </u>	Under NO circumstances is ANYONE who has been overseas in the previous 14 days or been in contact with a						
	person who is known to be COVID-19 positive, permitted to attend the Circuit.						
	All Essential Karting Personnel and Permitted Persons MUST:

4.	HYGIENE FACILITIES - TOILET/WASHROOM FACILITIES and HAND SANITISER

4.4	It is strongly recommended that Essential Karting Personnel and Permitted Persons bring their own supply of hand				
4.4	sanitiser for use in accordance with government recommendations.

5.1	The sharing of any equipment including but not limited to: tools, apparel, safety equipment, pens is not permitted.
