1.2.	Any person who starts to feel unwell or to exhibit symptoms of COVID-19 during the Activity must immediately				
1.2.	avoid contact with all persons at the Circuit and MUST IMMEDIATELY LEAVE the Circuit.				
	No more than five (5) Essential Karting Personnel may be at the Circuit for the purpose of conducting the Activity.				
	Essential Karting Personnel is defined as:

	Administration and Access Control Attendant/s.

	A Licensed Driver (Driver) in the COVID-19 Restricted Social Karting activity who has booked their entry in the				
	session plus one other person per kart who must be either:				
	The Parent or Legal Guardian of the Driver; or

	<ul> <li>A Mechanic whose sole task it is, is to prepare, adjust, repair the kart as may be required.</li> </ul>

1.5.	Non-Permitted Persons – there is NO PUBLIC ACCESS and NO SPECTATORS are permitted to be in attendance.				
1.6.	All Permitted Persons in attendance must be the holder of a Karting Australia Licence.				
	For the avoidance of doubt, this Licence can be a Driver, Participant or Pit Crew Licence.				
1.7.	A Permitted Person attending the Activity must leave the Circuit as soon as they have completed their driving or as				
	soon as their Session is finished, whichever is the sooner.				
	SOCIAL DISTANCING AND DENSITY REQUIRMENTS (Note – the number chosen in 2.1 must not exceed the				
2.	maximum number of people permitted to gather under Government Directions.)				
2.1.	Essential Karting Personnel and Permitted Persons are not permitted to gather in groups greater than 100.				
2.2.	Government prescribed Social Distancing measures must be observed at all times.				
2.3.	Permitted Persons MUST NOT park or set their Pit up within 5 metres of another Permitted Person's Pit space.				
2.4.	The use by Permitted Persons of any indoor facilities (other than toilets and washrooms) is strictly prohibited.				
2.5.	If food service is provided, it must comply with government requirements and be take away only.

	completed COVID-19 Declaration.				
	<ul> <li>If the confirmation email is not sent to the Club on time, you will not be granted access to the Circuit.</li> </ul>				
	<ul> <li>If you have been overseas in the 14 days before the Activity or if you have been in contact with a Covid-19</li> </ul>				
	Positive person, you will not be granted access to the Circuit.

4.4	It is strongly recommended that Essential Karting Personnel and Permitted Persons bring their own supply of hand				
	sanitiser for use in accordance with government recommendations.

5.1	The sharing of any equipment including but not limited to: tools, apparel, safety equipment, pens is not permitted.
